BY SIGNING THIS AGREEMENT, THE PARTICIPANT AFFIRMS HAVING READ IT.

IN CONSIDERATION of my involvement in the sport and activities under the auspices of the World Figure Sport Society, World Figure Sport’s Board of Directors, Officials, ORDA, Sharper Edge, and sanctioned by World Figure Sport and the Ice Skating Institute, I acknowledge, appreciate, and agree that:

- I. I RISK BODILY INJURY/ILLNESS, INCLUDING PARALYSIS, DISMEMBERMENT, DISABILITY, AND DEATH, AND while particular rules of my sport, equipment, and personal training and discipline may reduce this risk, THIS RISK OF INJURY/ILLNESS DOES EXIST, AS WELL AS THE RISK OF DAMAGE TO OR LOSS OF PROPERTY.
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS;
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual or unnecessary hazard during my presence or participation, I will bring such to the attention of the nearest official; and
4. I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES, and NEXT OF KIN, HEREBY RELEASE, HOLD HARMLESS, and PROMISE NOT TO SUE the World Figure Sport Society, World Figure Sport’s Board of Directors, ORDA, OR OTHER SPONSORING or SANCTIONING ORGANIZATIONS, THEIR OFFICERS, VOLUNTEERS, STAFF, VIDEOGRAPHERS, PHOTOGRAPHERS, SPONSORS AND/OR AGENTS ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY/ILLNESS AND LOSS ARISING FROM MY PARTICIPATION WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIGENCE OR WANTON MISCONDUCT.
